

INCOME TAX ALLOWANCES

The IBMS subscription is approved by the Board of HM Revenue and Customs as an allowable deduction under Section 201 of the Income & Corporation Taxes Act 1988.

To make a claim you will need to send form P87 with your self-assessment return, if you make this annually, or you can send it directly **to your local tax office**. Forms are available from the HM Revenue & Customs.
