We have used your feedback to upgrade our membership services, ensuring you have the support you need to deliver safe, high-quality services and opportunities to demonstrate high standards of professionalism.



Supporting **Our Members**

Enhancing Member Services

We are continuously looking for ways in which we can improve what we offer our members.

Key Highlights from 2014

- We launched an eStudent membership offer and attracted over 1,000 new members.
- Our website had almost 656,000 hits and was visited by just over 377,000 people throughout the year.
- We have grown our social media presence; we reached almost 13,000 followers on our Facebook page, almost 4,000 on Twitter and increased our LinkedIn Group to almost 6,000.
- Our e-newsletter sends news and developments straight to the inbox of almost 21,000 members and stakeholders every month.
- On average, over 1,400 members used our online CPD system every month.
- The Biomedical Scientist carried over 100 articles from members discussing scientific advancements, case studies and best practices in their disciplines.

- Our Legal Assistance Helpline supported over 300 members with a variety of problems relating to employment, family and consumer disputes, and property issues. Members can access the legal helpline by visiting www.ibms.org/legalhelpline.
- We updated our Group Medical Malpractice Insurance provision for Institute members to reflect the new HCPC indemnity insurance requirements.
- We ran a series of events throughout the UK on the topic of the ISO 15189 standards for laboratories and their implementation.
- Following feedback from members, our forum permits anonymous online discussion about scientific and professional issues.

Plans for 2015

- We are developing a new website that will provide easier access to services and improve member interactions online.
- We will be holding a number of careers events for our student members to help prepare them for the transition from studying to employment.
- We will film training courses and make them available to members on the website.

- We will consult with members on the creation of a new Welsh region to enable us to better support members living or working in Wales.
- We will support members in regions with no active branches to run events and establish branch committees.
- We will offer more networking opportunities for our Fellows.

Key Highlights from 2014

- We made changes to our membership criteria to ensure they are clear, concise and reflect both the academic and vocational achievements of all sectors of the biomedical science workforce.
- We supported members at all professional levels to achieve recognition through the Science Council registers. Eight Registered Scientist Technicians, 20 Registered Scientists and 98 new Chartered Scientists were registered throughout the year.
- Our members around the country supported the International Federation of Biomedical Laboratory Science (IFBLS) celebrating International Biomedical Laboratory Science Day.
- Vice President, Mr Edward Welsh CSci FIBMS, represented the Institute at IFBLS meetings.
- Vice President, Mr James Kenneth Rae CSci FIBMS, represented the Institute at the European Association for Professionals in Biomedical Science (EPBS) meetings.
- Mr Alan Wainwright CSci FIBMS, Executive Head of Education, addressed the World Congress of Biomedical Laboratory Science in Taiwan on "The Relevance of Learning Outcomes to Professional Practice".

Plans for 2015

- We are continuing to focus our marketing efforts on supporting members in new environments.
- We are creating a stakeholder management plan to further develop stakeholder relationships.
- We are launching our international strategy to increase our influence, grow our membership, and extend our reach in the international arena.

Building links with industry


The Institute is fortunate to have over 70 company members. By advertising in our publications and exhibiting at Congress, they help support these activities. They also play an important role in developing our members' knowledge of the latest technology.

In 2014, we met with our company members to ask how we can better support them. As a result, we now offer them a weekly news update and use of a meeting room at Coldbath Square.

Professional Development and Standard Setting

High-quality, relevant qualifications and training are the keys to ensuring a qualified biomedical science workforce. Our members told us that professional recognition and qualifications were two of the most popular benefits of membership.





Key Highlights from 2014

- We accredited 17 BSc honours degree programmes, including two in healthcare science, and eight MSc degrees.
- We have issued over 350 Certificate of Achievement portfolios and awarded 45 certificates.
- Over 24,000 online journal-based learning exercises were completed by members.
- We issued almost 700 CPD Diplomas and received almost 900 CPD validations.
- We awarded over 750 Certificates of Competence and over 300 Specialist Diplomas.
- We issued over 500 Registration portfolios and over 600 Specialist portfolios.
- Over 100 candidates completed our distance learning programmes to be awarded the Institute's Certificates of Expert Practice in Quality Management, Training and Leadership and Management.
- Following feedback from members, we have made a number of changes to our ePortfolio to make online CPD easier to use – members are now able to add, edit and delete activities, and attach reflective practice statements.
- We launched Institute policies on Staffing and Workloads in Clinical Diagnostic Laboratory Services, Supervision of Biomedical Support Staff and Management of Laboratory Training and reviewed our Code of Conduct.
- We have announced a pioneering joint venture with Thermo Fisher Scientific to promote excellence in laboratory practice, using education and CPD resources.

Plans for 2015

- We are launching the Diploma in Biomedical Science to enable the recognition of structured, standardised post-registration training and assessment of registered biomedical scientists in newly emerging multi-disciplinary services.
- We will seek approval from the HCPC as an education provider offering equivalence routes that recognise relevant academic and professional experience in respect of biomedical scientist and clinical scientist registration.
- We will determine the types of qualification that would be suitable for developing the role of biomedical scientists in areas of practice such as molecular pathology, genomics and point-of-care testing.

Advisory Panels (APs)

Through our eight discipline-specific Advisory Panels, we provide scientific and professional expertise, knowledge and advice to guide the Institute in determining policy, developing publications, advising governments, and informing the media. The members of our panels are recognised for their experience and expertise, which is used to further biomedical science and the work of the Institute.

Key Highlights from 2014

- Played a key role in organising the science lecture programmes for the Biomedical Science Congress 2015.
- Developed Institute qualifications, including the new Diploma in Biomedical Science and the Advanced Specialist Diploma in Non-Gynaecological Cytology.

- Introduced new prizes for the candidates who achieve the highest mark, on first sitting, in both the Diploma of Expert Practice and Advanced Specialist Diploma examinations.
- Provided online journal-based learning.
- Provided discipline-specific input into applications for the Institute's research grants.
- Provided verifiers and examiners for the Institute's Registration and Specialist Portfolios and other qualifications.
- Identified a number of nominees for Institute representation on external, local, national and government committees.
- Reviewed Institute publications and contributed to external consultations.

Plans for 2015

- We will lead on the development and delivery of the scientific programme for Congress 2015.
- In collaboration with RCPath, we will establish a Conjoint Board for Biomedical Scientist Reporting of Histopathology in gastrointestinal and gynaecological pathology.
- We will contribute expert opinion to external consultations.
- We will prepare the 2015 Institute examinations.

Honorary Membership

Honorary Membership of the IBMS is awarded in recognition of an individual member's significant contribution and support to the Institute across a number of years. In 2014, Honorary Membership of the Institute was awarded to Brian Dale CSci FIBMS.

RJ Lavington Prize

Established in 1977 in memory of the man who was General Secretary of the Institute for 22 years (1948–1970), this prize is awarded annually to the candidate who, at the first attempt, receives the highest mark in the Higher Specialist Diploma (HSD) examination across all disciplines. The 2013 RJ Lavington Prize was awarded to Jill Caulfield CSci FIBMS for her examination result in Transfusion Science.

Mary Macdonald Prize for Achievement and Bursary

This was established in the memory Mary Macdonald CSci Fellow, who made a significant contribution to the Institute throughout her life.

The first Mary Macdonald Bursary was awarded to Jill Beavers, a Medical Laboratory Assistant based in the Clinical Biochemistry department at North Tyneside General Hospital.

The first Mary Macdonald Prize for Achievement was awarded to Pavanjit Jheeta, a Medical Laboratory Assistant at City Hospital, Sandwell & Birmingham Hospitals NHS Trust. Holly Keyes, a Medical Laboratory Assistant based in the Haematology department of the Royal Bournemouth Hospital, was awarded the second Mary Macdonald Bursary.

Research Grants

Institute research grants are awarded annually to members to support original investigations and other suitable research work. The grants awarded are usually between £500 and £5,000. In 2013/14, we awarded £18,300 of research grants.

President's Prize

We sponsor an annual prize for one student graduating from each university that offers an Institute accredited BSc (Hons) degree programme in biomedical science. Each university or college awards the prizes according to its own defined criteria to graduates who achieve high academic distinction. During 2013/14, we awarded 46 prizes. The Institute engages with a wide audience to communicate the value of biomedical science through events, sponsorship, social media and media relations.

Advocacy





Our members told us that it was important for the Institute to represent them with governments, employers and higher education institutions. Members wanted to see that we were representing their interests in key areas, including NHS reform, regulation and promoting the role of biomedical science in society.

Key Highlights from 2014

- We have continued to work with our Advocacy Focus groups to hear views from our members about how we can influence policy and raise our profile.
- We have continued to post brief reports from Council Members who attend external events on behalf of the Institute on our website.
- Our members were involved in hundreds of events to raise the profile of the profession, including National Healthcare Science Week, and the annual School Science Conference at the Glasgow Science Centre.
- Our President, Council Members and Chief Executive have attended events to ensure members' views are represented in the areas members deem crucial for the profession, including the Department of Health's Pathology Quality Assurance Review.

- We have raised our profile through media coverage in Newsweek, the British Journal of Healthcare Management, Science in Parliament, and local press.
- We were sponsors of the Biological and Biomedical Sciences session of SET for Britain that supports early career researchers and future scientists. SET for Britain is organised by the Parliamentary and Scientific Committee with the aim of supporting and promoting the work of early career researchers in the UK.
- We awarded the first Institute eStudent British Science Festival Bursary, which offered member Dee Kulaveerasingam the chance to gain experience in communicating science to the public.
- Working with Glasgow City of Science and local primary schools, we successfully smashed the world record for the largest simultaneous hand hygiene lesson at multiple venues.
- The History Committee assisted other bodies and organisations, including the BBC and RCPath who were putting together exhibits and talks relevant to the history of biomedical science.

Organisational robustness

We want to build an effective and efficient organisation that is sustainable, with the capacity to deliver our mission effectively.

To achieve this, we need to utilise new technology, and attract and retain high-calibre staff to offer the best possible support to our members and other stakeholders.

Highlights from 2014

- We reviewed our membership database system, with a view to offering enhanced access for members via the membersonly section of the website and improving communication channels.
- We continued to improve our operational efficiency and deliver value for money through sound financial and risk management and strengthening of internal controls.
- We expanded our History Committee, recruiting Mr Stephen Mortlock CSci FIBMS, Mr Lee Peters CSci FIBMS and Mr James Kenneth Rae CSci FIBMS. Our thanks are extended to Mr Anthony Harding FIBMS (Chair 2008–2014) and Mrs Jocelyn Germain FIBMS for their valuable contribution over the years.

Plans for 2015

- As part of our commitment to open and transparent governance, we will extend the opportunity of members observing Council meetings to include the key standing committees.
- We will seek to include lay members in Institute governance.
- Vice President Mr James Kenneth CSci FIBMS is arranging to record and catalogue the instruments and equipment held by the Institute.
